We agree to be responsible for, and pay all bills for any medical, optical, dental, pharmaceutical, or similar services (a) required by our child while in the host country, and (b) not covered or paid by the company issuing the medical and hospital insurance. 13. We shall be responsible for, and pay, all legally enforceable debts incurred by our child while in the host country. If YFU discharge any such debt, whether due to emergency, as a matter of convenience or otherwise, we agree to repay such amounts to YFU immediately on demand.
14. We understand that in making travel arrangements for our child, YFU contracts with or uses commercial airlines, trains, buses, restaurants, hotels and other entities whose performance and services cannot be controlled by YFU. Consequently, we agree that YFU is not liable for any of the actions of such commercial entities, including, but not limited to, lost baggage, uncomfortable quarters, and travel delays. We further agree that YFU reserves the right to change or alter travel, lodging, or any other arrangements if YFU believes such change or alteration to be in the best interests of the participants or Program.

We authorise YFU, its employees and representatives, and adult members of our child's host families, to act for us in any emergency, accident, illness, or injury involving our child, and agree to release and discharge YFU and the foregoing individuals from any liability, claims, or demands that may be asserted in connection with:

- a. any emergency, accident, illness or injury or other consequences or event arising from the actions or participation of our child in the Program, or
- b. any cause, event or occurrence beyond the control of YFU, including, but not limited to natural disasters, war, civil disturbances, and the negligence of parties not subject to YFU's control.
